

Finnish Suppliers

Finnish Suppliers is a digital service by which exporting companies can promote their supplies and services. At the same time, it is an information source for entities looking for Finnish export companies and their target markets. Searches can be made based on multiple criteria, such as the type of service provided, target market (Country), or Industry sector. Terms and conditions for users of Finnish Suppliers

These Terms of Service (“Terms”) govern your access to and use of Finnish Suppliers, including websites, email notifications, applications, buttons, widgets, (collectively, the “Services”), and any information, text, graphics, photos or other materials uploaded, downloaded or appearing on the Services (collectively referred to as “Content”). Your access to and use of the Services are conditional on your acceptance of and compliance with these Terms. By accessing or using the Services you agree to be bound by these Terms.

The Services are owned and operated by Business Finland Oy, Porkkalankatu 1, P.O. Box 358, 00181 Helsinki, Finland (“Business Finland”).

Basic Terms

If you are using the Services and accepting these Terms on behalf of the legal entity, you represent and warrant that you are legitimately authorized to do so, and that the entity you are representing are bound by these Terms.

You are responsible for your use of the Services and for any consequences thereof.

The form and nature of the Services may change from time to time without prior notice to you. In addition, Business Finland may stop (permanently or temporarily) providing the Services (or any features within the Services) to you or to users generally and may not be able to provide you with prior notice. Business Finland also retains the right to create limits on use and storage at its sole discretion at any time without prior notice to you.

Intellectual Property

All right, title and interest in and to the Services (excluding Content submitted by others than Business Finland) are and will remain the exclusive property of Business Finland and its licensors. Business Finland does not endorse, support, represent or guarantee the completeness, truthfulness, accuracy, or reliability of any Content or endorse any opinions expressed via the Services.

Rights and use of Content

The Content is provided for users in order to make it easy to search and identify Finnish exporting companies within the Service.

The rights to any Content belong to the one who submitted, posted or displayed it on or through the Services. You obtain no rights to the Content submitted by others except the limited right to use the Content as stated herein. Exporting or copying data from the Service for other purposes than for internal purposes of the entity you are representing, is prohibited.

Force Majeure

Changes to these Terms, Termination

If, however, your domicile is or you are representing an entity domiciled outside EU/EEA, Business Finland has the right to submit any claims to the jurisdiction of the local courts of your domicile/the entity's domicile you represent.
