



Europe in a changing world - Inclusive, innovative and reflective societies

These calls for 2020 are subject to change until the final work programme is published in July 2019. Please check the final published work programme before starting submission.

Pressure from increased migration flows, socio-economic and cultural transformations from new forms of human-technology interaction under the fourth industrial revolution, and new developments in European, national and global governance have the potential to significantly impact Europe's future at many levels. At the same time, and linked to these developments, the citizens' trust in many public institutions and their capacities to address effectively these challenges is weakening while their concerns are increasing.

In the light of these challenges, the scientific and innovation priorities of SC6 under work programme 2018-2020 are focused around three major themes: migration, socio-economic and cultural transformations stemming from the fourth industrial revolution, and governance for the future.

The SC6 work programme contributes in total five actions to the Focus Area on the Security Union (Boosting the effectiveness of the Security Union) and eight actions to the Focus Area on Digitisation (Digitising and transforming European industry and services). These actions are identified by the acronyms SU and DT in topic titles.
