# An example: SU-GOVERNANCE-09-2020: Addressing radicalization through social inclusion

**Specific Challenge:** The spread of radical ideologies leading in some cases to violence has prompted the EU and its Member States to develop prevention policies and effective intervention scenarios supporting social inclusion. To further develop and proactively target the needs of policymakers and practitioners, a comprehensive evidence base analysis on trends in radical ideologies and extremism and on the drivers of polarisation and radicalisation is necessary.

Scope: Based on empirical and multidisciplinary approaches, proposals should assess the multiple drivers and manifestations of radical ideologies prone to incite or lead to violence, both societal (including religious) and political, as well as the physical and online contexts for their propagation. Complementary knowledge on non-radicalising identity, belonging, disengagement and detachment should also be formulated in order to provide a holistic framework for assessing and proposing preventive measures in terms of social policies and interventions. A focus should be on the psychological and social mechanisms of alienation and radicalisation of youth in urban and periurban contexts. Research should develop new methodologies, where appropriate and evidence based policy recommendations in close collaboration with civil society and policy makers. Proposals should rely on extensive fieldwork and construct a solid empirical base. Research must consider gender perspective where relevant.

# An example: SU-GOVERNANCE-09-2020: Addressing radicalization through social inclusion

The Commission considers that proposals requesting <u>a contribution from the EU in the order of EUR 3 million</u> would allow this specific challenge to be addressed appropriately. This does not preclude submission and selection of proposals requesting other amounts.

<u>Expected Impact</u>: Actions should provide <u>a holistic evidence base</u> to support situation analysis. They should <u>increase the capacity</u> to quickly identify and reach at-risk groups and thereby <u>contribute to</u> better targeted and more effective policies and interventions, <u>as well as identify</u> their optimal implementation tools. The ultimate goal is <u>to</u> <u>increase awareness and resilience</u> in at-risk demographics and introduce preventive, countering and de-radicalisation approaches as applicable.

Where applicable the proposals should demonstrate how they will effectively build on the relevant previous and on-going EU funded (including but not limited to the Horizon 2020 both Societal Challenge 6 and 7, and Internal Security Fund - Police) radicalisation projects.

# Elements of an excellent proposal - lessons learnt from evaluations\*

#### **Ambition and novelty**

- Demonstrates a thorough understanding of the issues underlying the call, and responds with appropriate objectives
- Well grounded in prior research in the area.
- Provides convincing plans to expand the current knowledge
- Selection of the participant countries represents European diversity
- Tools/resources/methodology are applicable in different contexts
- A strong interdisciplinary approach
- Relevant stakeholders' knowledge and experience are appropriately used

# Elements of an excellent proposal - lessons learnt from evaluations\*

#### **Expected impact**

- The plan to inform policy is convincing as it includes a liaison with institutions at national, international and EU levels
- The project will have a positive impact on society, because stronger ties will be developed between local communities and public institutions
- There is an excellent dissemination and exploitation plan tailored to specific end-user needs / to various target audiences
- The project moves beyond traditional modes of delivery and provides web seminars, stakeholder consultations and training, as well as dissemination in social media and a dedicated webpage
- The tools and knowledge will be applied and further developed beyond the timescale of the project



# Elements of an excellent proposal - lessons learnt from evaluations\*

#### **Efficient and credible implementation**

- The consortium partners have collaborated on previous projects and have good track records.
- An outstanding consortium in terms of country participation and expertise, and has very good geographical coverage and wide multidisciplinarity.
- Work plan is differentiated according to the different stages of the research.
- The timeplan and division of labour are clear and balanced.
- Adequate provision for strategic management, monitoring of the research project and quality assurance (f.ex. GA, team leaders' meetings, advisory board, internal peer review panel).
- There is clear responsibility for risk management, as well as an appropriate approach to risk identification and mitigating strategies are set out
