




Lasse Mäkelä Co-founder & CEO, Invesdor Group




LEADER IN DIGITAL FUNDRAISING

We have been digitalizing the investment process with the goal of making investing fair, easy and accessible to everyone. Many companies in our field stay local. Not us. Our license allows us to operate in 28 European countries — we are a European player who makes digital investing and fundraising cross-border smooth and simple.

We merged in 2019 with the Austrian company Finnest, forming a pan-European Invesdor Group and opening new markets for investors, target companies and ourselves. Our target companies come from the Nordics and the DACH region, our investors from almost anywhere in the world.

Our HQ is located in Helsinki and we have offices also in Stockholm and Vienna.






FIND OPEN FUNDING ROUNDS All our target companies go through our due diligence process. We also provide an investor forum where you can


direct questions to fundraising companies.



...AND A HIGHER TOTAL OF FUNDING RAISED ANNUALLY




Annual funding raised on Invesdor's platform (millions of €)






GOING CROSS-BORDER REQUIRES TIME AND PATIENCE

- Invesdor focused in 2016 on entering the UK but progress on the market was slow. 2017-18 brought us organic growth in Sweden but the challenge remains the same: it is a slow process growing on a new market.
- 2019: Joining forces with Austrian fintech platform
 Finnest and opening up the DACH region. We are
 making a big push with a great partner in Finnest: this
 feels like the right formula for us.
- Key lesson: going cross-border and international is always harder than what you initially believe it to be – but hard effort will pay off. The trick is to keep trying!

- Invesdor is recognized as the place to invest in the future of European business.
